In 2008 his thesis «Imperatives of System Interaction in Global Economy Formation» was approved for obtaining a doctoral degree in the field of International Economics.


During the period from 1998 to 2005 he taught such courses, as: International Financial Management, International Management, International Economics, Transnational Corporations, International Organizations, and International Trade.


Currently, Oleh Shvydanenko teaches the following courses: "International Economics", "Management of International Competitiveness", "Global Competitive Leadership".
